COBRA Subsidy & Unemployment Insurance Extension Was Signed Into Law

On December 19th Congress voted to extend the employer COBRA premium subsidy from December 31, 2009 to February 28, 2010. This also includes providing a retroactive period of 60 days for payment of premiums for eligible individuals whose subsidy period expired on Nov 30, 2009 as reported by SHRM HR Voice.

Unemployment Insurance has been extended from the current end date of December 31, 2009 to February 28, 2010 and the period during which individuals may claim and be paid unemployment compensation (EUC) is extended from May 31, 2010 to July 31, 2010 also reported by SHRM HR Voice.

ICE Audits & Purging I-9s

Purging I-9s at the end of the year can be a difficult task when reports of ICE audits are in the news. The guidelines for purging I-9s requires the shredding of all I-9s in which the employee is no longer working, and must follow these rules: three years after the hire date or one year after termination, whichever is later.
